III. Finance Committee Report for St. James Anglican Church

- a. June Results June's income exceeded the June Budget. However, some parishioners gave the rest of their yearly pledge this June. Expenses have continued to be less than budgeted. Thank you Pastor Brian for keeping our expenses in line.
- b. Priorities for Finance Committee were given by Dave Chapman. The finance committee will continue to work on the following items.
  - 1. Month to month income and expenses
  - 2. Update Employee Handbook
  - 3. Create Administrative Procedure Manual
  - 4. Create Administrative Calendar
  - 5. Clarify investment strategy for funds that have been donated for the building fund.
- c. Motion to accept the financial report as presented was made by Bev Lucas and seconded by Bob Kirkland. Motion carried.

#### IV. Full Time Employee Benefits Discussion

- a. Benefits that will be accrued by a full time employee:
  - i. Nine paid holidays
  - ii. Vacation days 6 months after hire date employee will earn 5/6 a day per month beginning the 7<sup>th</sup> month after hire date.
  - iii. No fiscal impact for vacation days.
  - **iv.** Two weeks of vacation after 1 year of employment. It was suggested that a maximum of 3 weeks of vacation be accrued.
  - v. Don will be checking with an HR expert to make sure our Employee Handbook is within the current labor laws stipulations.
  - vi. Sick Leave There will be nine paid sick days per year. It does not accrue.
  - vii. Short Term disability and Long Term disability is currently being covered by the church.

b. Motion to affirm full time employees will receive 9 paid holidays, 5/6 of a day vacation day beginning the seventh month of employment, and 9 days of sick leave per calendar year was made by Pastor Brian and seconded by Terri Boykin. Motion was approved.

#### V. Rule of Life Video Series Presentation

- a. The Rule of Life means to intentionally structure your life around certain rhythms to grow your life spiritually.
- b. On Sunday, August 8, after the 10 am service, an adult education class will be taught by Maryl DeMilo.
- c. Students will watch each of 6 videos. Videos will appear in weekly e-news and on the website.
- d. Ask Patricia Streeter to proofread the brochure before publication.
- e. Maryl's birthday is July 25. Vestry to send her a card and perhaps a gift.

#### VI. Women's Conference September 24 and 25, 2021

- a. Yahna Jackson's conference is planned for Sept. 24 and 25, 2021.
- b. Reach out and invite your neighbors.
- c. Make sure that the invitation tells what the conference is about.
- d. Conference's purpose is to strengthen the soul, prayer, and fellowship.

#### VII. Annual Meeting Initial Plans Discussion

- a. We would like to see the maximum number of people attend the annual meeting.
- b. Meeting would include planning for the next year.
- c. A meal is preferred and some people feel that alcohol needs to be available.
- d. Bob Kirkland will be checking with Newport Ribs to see what the cost will be to have the annual meeting at the Costa Mesa Country Club.
- e. Bob will also determine what the cost will be to have the meeting at the church on Sunday. Church parking on Sunday is until 1:30 pm.
- f. October 21, 2021 is date specified in the Church's Bylaws for the Annual Meeting.

## VIII. St. James 80<sup>th</sup> Anniversary Celebration - Initial Plans Discussion

- a. We had the 75<sup>th</sup> anniversary at the Pacific Club. Myron Steeves is a member of the Pacific Club.
- b. Invite former members of the church.
- c. Frank Trane's Memorial was sort of a reunion.
- d. Plan a worship service to include the Annual Business Meeting and to also celebrate the church's 80<sup>th</sup> Anniversary with a live band and a meal or cake afterward.
- e. Start service at 9:30 am.
- f. Annual Meeting and the Church's 80<sup>th</sup> Birthday celebration will be tentatively planned for October 24, 2021.

 g. The Vestry agreed to have a combination Worship Service, Annual Meeting and 80<sup>th</sup> Birthday service with a meal afterward on October 24, 2021.

- d. We will need to change out the tables and chairs in SS classroom to seat 7-12 graders.

## **VESTRY RESOLUTION**

On July 15, 2021, the Vestry of Saint James Anglican Church approved the following Motions:

- (1) Moved, that the Vestry gives permission for David Chapman, on behalf of St. James, to enter into discussions with Soteric Academy to determine the viability of subleasing our classrooms and other rooms for a period of 2-5 years;
- (2) Moved, that should the intended use of the property and initial terms of a lease be favorable to both parties, David Chapman will contact the Property Owner to seek permission to sublease our space to Soteric Academy;
- (3) Moved, that should the Property Owner deny Saint James' request for signing a sublease, all further discussions and negotiations with Soteric Academy will cease;
- (4) Moved, that should the Property Owner approve Saint James' request for signing a sublease, The Rev. Brian Schulz and David Chapman will negotiate the final terms of the sublease agreement;
- (5) Moved, that the final terms of the sublease must be approved by a majority vote of the Vestry before the lease documents may be signed;
- (6) Moved, that signers on the sublease agreement will be Brian Schulz and David Chapman.
